Your information is being collected to use for the following purposes:

- Full name, date of birth, postcode and contact details (email, mobile or landline phone no) are collected from participants who partake in physical activity programmes organised by the Moray Health and Social Care Partnership, Moray Council, Moray Leisure Centre and Moray Sports Centre to enable these organisations to maintain communications with programme participants.
- Gender information is collected for equity and performance reporting
- Medical details are collected, on a self-declaration basis where participants have conditions we need to be aware of in order for them to use the facilities and participate safely in the classes available to them

- Emergency Contact Details are collected from participants to enable these organisations to have an alternate contact connected to the participant for emergency purposes
- Healthpoint staff will securely store all personal data in a secure electronic/password protected site. The personal data will only be retained for the length of time defined by Moray Health and Social Care Partnership within their data protection legislation.
